\*Donations to the Land Acquisition Fund are used to purchase critical privately-owned lands within the Glacial Lake Grantsburg project boundaries. The fund is designed to be a revolving source of money to acquire the land and hold it until the State of Wisconsin can buy it back from us. Upon repayment, we return the money to the fund and it is ready for the next land conservation project. Dollar for dollar, the Land Acquisition Fund can protect numerous pieces of land from development. It's the gift that keeps on giving. \*Donations to the General Fund are used to support the day-to-day operations of the Friends of Crex, as well as pay the wages of the support staff, which includes two LTE's, Natural Resource Educator who takes care of the memberships and financial bookkeeping of the Friends of Crex, and a Natural Resource Educator who conducts Wildlife Education programming at Crex Meadows. This fund is liquid and can be used as needed. Membership dues, (except for Lifetime Memberships) are placed into the General Fund.
